

**MEMORANDUM OF AGREEMENT
BETWEEN
THE WATERTOWN EDUCATORS ASSOCIATION
AND
THE WATERTOWN SCHOOL COMMITTEE
March 9, 2017**

This **MEMORANDUM OF AGREEMENT** is entered into by and between the Watertown Educators Association (hereinafter the "Association") and the Watertown School Committee (hereinafter the "Committee") on behalf of Unit C.

WHEREAS, the Association and the Committee entered into a collective bargaining agreement for the period September 1, 2014, through and including August 31, 2016; and

WHEREAS, the Association and the Committee have bargained collectively pursuant to Massachusetts General Law, Chapter 150E, for a successor collective bargaining agreement for the period September 1, 2016, through and including August 31, 2019;

NOW, THEREFORE, in consideration of mutual covenants and promises and subject to the ratification of the respective parties, it is agreed as follows:

The terms and conditions set forth in the Collective Bargaining Agreement for the period September 1, 2014, through and including August 31, 2016, shall continue in full force and effect for the period September 1, 2016 through and including August 31, 2019 except as amended herein.

Article V Salaries and Other Compensation

Modify Section A.3.c. to say:

"Any member of Unit C required by the Superintendent or designee or their building principal to report to work for more than his/her contractually agreed-upon days shall be compensated at the per-diem rate of the member in effect during the additional days worked."

Article V Salaries and Other Compensation

Increase longevity amounts as follows:

Administrators upon completion of the following years of service to the Town of Watertown shall receive the following amount added to his/her salary.

Years of Service is defined as years completed in the Watertown Public Schools.

Article VII Hours and Workload

Modify section A. Work Year to say:

Unit C Members will serve the following number of days:

Housemasters/High School Dean of Students/Assistant Principals: 205 days

Pre-school Director: 200 days

Athletic Director: 210 days

Amend Section C: Evening Meetings as follows:

Unit C members may be required to attend up to ~~six (6)~~ eight (8) evening meetings each year. Except in the event of extraordinary circumstances, Unit C members shall be notified of evening meetings at least one week in advance. Attendance at all other evening meetings shall be at the option of the individual Unit C member. **If a Unit C member is requested by a principal, the superintendent, the assistant superintendent, or designee, to attend more than eight (8) evening meetings, the Unit C member will be compensated at the rate of \$100 for each requested meeting following the initial eight.**

Article XIV Temporary Leaves of Absence

Modify Section 8.5. to be entitled "**Bereavement Leave**"

Modify Section B.5.b. To read "**(5) days**" rather than "**(3) days**".

Add a new section B.5.d. As follows: "**If an administrator must travel to attend the services of a deceased relative from a class named in parts a. and b. above, and that travel necessitates a leave beyond 5 days, the administrator may apply for additional/eave, beyond the 5 days otherwise permitted, by submitting a written request to the Superintendent stating the travel necessary and the exact amount of days requested. The Superintendent or designee shall decide whether to grant the leave sought and that decision shall be final, binding and not subject to the grievance and arbitration process. In the event the leave is granted, accrued unused personal days shall be the sole means of compensating the administrator for the additional time out.**"

Article XIV Temporary Leaves of Absence

Modify Section B.6. to add the following sentence after the first sentence: "**Up to five (5) additional bedside care days may be taken through the deduction of one's personal sick leave accumulation.**"

Article XIII Sick Leave

Amend Section C.2. to read "**no Unit C administrator shall receive more than ninety (90) days**"

Article XIV Temporary Leaves of Absence

Modify Section B. 7. (adoption leave) to replace the word "principal" with "**principal or immediate supervisor**".

Article XVII Professional Development and Educational Improvement

Replace the words "Staff members" starting paragraphs 2 and 3 with "**Unit C members**"

APPENDIX A

Modify Appendix A as follows:

Increase the salary schedule by 2.25% effective September 1, 2016;

Increase the salary schedule by 2% effective September 1, 2017;


Increase the salary schedule by 2% effective September 1, 2018.

Appendix A, Section A


Increase the stipend for CAGS to \$2,500 and for Doctorate to \$4,000.

The parties further agree to merge existing contract MOAs into a single contract document and clean up entire contract for clarity.

WHEREFORE, the Committee and the Association have caused this **MEMORANDUM OF AGREEMENT** to be executed, subject to ratification by both parties by their duly-authorized representatives this 5th day of April, 2017.
